Course Description:

This course introduces economic issues related to the environment and policies that can be used to address them. Topics covered in this course include (but are not limited to) the following: Externalities, Open Access Resources, Cost Benefit Analysis, Revealed Preferences, Stated Preferences, Social Choice, Economic Growth and the Environment, Net Present Value, Environmental Policy (including Standards, Fees, and Marketable permits), Law and the Environment.

Course Objectives: Students that successfully complete this course will be able to:

- (i) understand some of the major environmental regulations in the United States of America
- (ii) understand different valuation methods for environmental goods
- (iii) identify different types of goods and policies aimed at incentivizing their socially optimal
- (iv) understand cost-benefit analysis of environmental projects
- (v) understand the economic implications of different types of environmental policies

Class Modality: This is a fully in-person course. Lectures will not be streamed nor recorded¹. All exams will take place in person, during our scheduled class times. The course does not have a final exam, but it does have a research paper and presentation at the end of the term.

Grading: The course grade is determined by your performance on two 100-minute exams (37.5% each), a research proposal and paper (20%), and a research paper presentation (5%), following the scale below:

Make-up assignments and exams will be arranged *only* for absences that are explicitly covered by the <u>UF Attendance Policy</u>. Whenever possible, you should reach out at least five business days in advance to arrange a make-up assignment or exam. Of course, this will not always be possible. Unforeseen absences and emergencies occur and can be excused without such advance notice. In most cases, you will be asked to provide evidence or documentation of an absence that is explicitly excused by the <u>UF Attendance Policy</u>. Absences related to religious holidays and worship do not require this documentation but must be given ahead of time if the holiday date is known ahead of time.

Exams: There are two exams in this course. These closed-book, closed-note exams will take place in our regularly assigned classroom. You may use a basic four-function calculator. Graphing calculators are not permitted. Partial credit will be given for partially correct answers. For questions involving math/graphs, points will be deducted if a student has the correct answer but does not show how they arrived at that answer. If a student arrives 20 minutes or more late to an exam, they will receive a grade of 0 on that exam. Please plan accordingly. Note: We have one asynchronous virtual lecture on Thanksgiving week with a quiz. That quiz is part of Exam 2 (worth 3% of your grade).

¹ The only scheduled exception to this is we will have an asynchronous virtual lecture on Thanksgiving week. This lecture and the work accompanying it is mandatory and part of your Exam 2 grade.

Research paper: Students will submit a research paper. The paper can be written individually or in groups of up to 4 students. If you work on a group, you are required to submit a document highlighting each student's contribution². If a student does not contribute to a paper, they can be expelled from the group up to 5 days before the assignment is due. The research paper must be submitted via Canvas. There's a 15-point penalty for each day that you are late submitting your paper. Late assignments relating to the research paper (even a few minutes late) will only be accepted if you have an excused absence and are subject to the make up policy stated above. In the case of expected absences, arrangements should be made at least five days in advance. Importantly, this policy means that you must arrive to class on time whenever your oral paper presentation takes place. Instructions on how to complete the proposal, paper, and presentation are posted on Canvas. Important: Uploading the wrong document to Canvas (including blank documents) is a preventable mistake. Always download papers and proposals submitted via Canvas to make sure you uploaded the correct document. I will not allow students to resubmit a paper to Canvas because they uploaded an incorrect file or a file that can't be opened. Your paper presentation score is based on your scheduled oral presentation and on attending and asking questions during your classmates' presentations.

Practice homework: Our Canvas course contains several practice homework you should complete. I have posted the homework individually and with answers. While I do not collect nor grade these practice homework, you should always complete them prior to the exam review. Historically, students who complete all of the posted homework are the students who perform the best in the class. You are encouraged to work with your classmates while completing these assignments. Working together can facilitate deeper learning of the course material and more efficient completion of the assignment itself. If you have trouble understanding any of the homework problems, please ask about them during class (there is a session dedicated to working on the homework) or attend office hours.

Professionalism and Honor Code: Students are bound to not cheat or plagiarize, and are bound by The Honor Pledge which states, "We, the members of the University of Florida community, pledge to hold ourselves and our peers to the highest standards of honor and integrity by abiding by the Honor Code. On all work submitted for credit by students at the University of Florida, the following pledge is either required or implied: 'On my honor, I have neither given nor received unauthorized aid in doing this assignment.'"

Extended Absences:

If you are out sick for a substantial period of time, and it is unlikely that you can reasonably get caught up in class, you can pursue a medical withdrawal by contacting the UF Care Team (https://care.dso.ufl.edu/). I generally recommend this route when a student misses 2+ weeks and when a student misses their make-up exam (in addition to their scheduled exam).

Recording of class:

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. The only allowable purposes are (1) for personal educational use, (2) in connection with a complaint to the university, or (3) as evidence in, or in preparation for, a criminal or civil proceeding. All other purposes are prohibited. Specifically, students may not publish recorded lectures without the written consent of the instructor.

A "class lecture" is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and delivered by any instructor hired or appointed by the University, or by a guest instructor, as part of a University of Florida course. A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or lecturer during a class session.

Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
