**Course Objectives** 

This course is an introduction to intermediate microeconomic theory. You will learn how to use differential analysis to solve household and firm optimization problems, but students should have a strong understanding of differential calculus. The course is divided into three: household decision making and consumer behavior, firm profit maximization/cost minimization in competitive markets, and imperfect competition and general equilibrium analysis.

# **Course Evaluation**

Your grade in the course will be determined by your performance on two midterms and a final exam as well as your participation during "in-class" assignments that we will be doing during class time throughout the semester.

The midterm exams will be administered in-class in place of a lecture that day and the dates of the midterms are tentatively scheduled for February 12th and March 12th. The final exam can be taken early on April 22nd and this exam will be noncumulative or it can be taken during the scheduled final exam date during final exam week (this exam will be cumulative). Depending on which final exam option you choose (you can only take one of the final exams) the calculations for your final course grade will be weighted as following:

#### **UF Recording Lecture Policy**
